





KRS: 218A.500(2) - Drug Paraphernalia - Buy/Possess (Class A Misdemeanor) (UOR 42081)

COUNT 1:

The Grand Jury charges that on or about February 18, 2024, in Taylor County, Kentucky, the above defendant possessed, manufactured or transported a firearm when he has been convicted of a felony as defined by the laws of the jurisdiction in which he was convicted, in any state of federal court and has not: been granted a full pardon by the Governor or by the President of the United States; Been granted relief by the United States Secretary of the Treasury pursuant to the Federal Gun Control Act of 1968, as amended or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges that on or about February 18, 2024, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possesses a controlled substance that is classified as a Schedule I or II, which is a narcotic drug, a controlled substance analogue; Lysergic acid diethylamide; phencyclidine; gamma hydroxybutyric acid (GHB), including its

salts, isomers, salts of isomers and analogues; or flunitrazepam, including its salts, isomers, and salts of isomers or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

The Grand Jury charges: That on or about February 18, 2024, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possesses: a controlled substance classified in schedules I or II which is not a narcotic drug or specified in KRS 218A.1415; or a controlled substance classified in Schedule III; but not a synthetic drugs, salvia, or marijuana or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:

The Grand Jury charges that on or about February 18, 2024, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia or aided, abetted or counseled with another in said act. Said act against the peace and dignity of the Commonwealth of Kentucky.
